

AGREEMENT TO ATTEND A HAPPY HOUR CHAMBER CONCERT

Each ticket holder needs to present a signed and dated copy of this agreement as well as the agreement with Epiphany Lutheran Church in order to be seated for the concert.

My signature on this document expresses my agreement and compliance with all of the following provisions of Happy Hour Chamber Concerts to protect patrons and artists for this concert that is taking place during the COVID pandemic:

- I have been fully vaccinated against COVID as of the date of this concert OR I am the parent/guardian signing for a child who is either vaccinated and between the ages of five and eighteen, or who is under the age of five who has not been vaccinated and who has received a valid negative COVID test: either a negative COVID-19 PCR test taken within 72 hours of the performance start time, or a negative COVID-19 antigen test taken within six hours of the performance start time.
- I agree to wear a mask during the time I am indoors at Epiphany Lutheran Church, for my sake and for the sake of others in the audience. As a parent/guardian, I will have my child/youth masked for the concert.
- I understand that there will be socially distanced seating and I may be asked to take an assigned seat in order to maximize the safety of all who are in attendance.
- I am coming to this concert symptom free as of the last twenty-four hours. I do not have a fever, cough, sore throat, or other COVID symptoms.
- I am willing to comply with the policies and requests of Epiphany Lutheran Church and Happy Hour Chamber Concerts.
- I acknowledge that Happy Hour Chamber Concerts is taking reasonable steps to limit exposure to the virus. However, since the virus has not yet been eliminated, I acknowledge that my presence at this concert may result in inadvertent exposure to COVID 19, especially if I (or my youth/child) is in an at-risk group. By my signature below, I express my understanding and agreement that I have understood and accepted these risks and am willing to assume responsibility for my own health and safety.

Epiphany Lutheran Church ELCA, in Denver, CO has adopted an ongoing strategy of following the recommendations of the CDC and other health agencies regarding reopening in order to protect the health of staff and visitors.

Privacy laws about protected health information do not allow us to screen, test, or obtain a full medical history from our guests, visitors, or staff. Therefore, we request and expect that any individual entering Epiphany Lutheran Church or organizer of any meetings or events that take place at Epiphany Lutheran Church , will monitor their own health or the health status of participants according to the General Health Policy, so that any exposure to the virus is reduced for staff and other visitors at Epiphany Lutheran church. Until further notice, masks are required as well as compliance to any other policy that may apply.

We will do our part in taking reasonable steps to limit exposure to the virus, but since the virus has not yet been eliminated, we are making full disclosure to all participants that your presence at Epiphany Lutheran Church may result in inadvertent exposure to COVID 19, especially for at-risk age groups. Until the all-clear is given by health authorities, your presence at Epiphany Lutheran Church, and any gatherings on the premises includes your express understanding and agreement that you have understood and accepted those known risks and are willing to assume responsibility for your own health and safety.

Epiphany Lutheran Church COVID-19 "General Health" Policy COVID Policy #1

Purpose: To ensure the safest environment possible for all those who come on Epiphany Lutheran Churches premises. Though it is impossible to identify everyone who may be infected with SARS- Cov2, the virus that causes COVID-19, this policy's goal is to help identify those who should not be on the premises and guided to interact with our faith community in other ways.

1. The COVID-19 virus can have a long incubation period during which carriers of the virus may not show symptoms and yet are still highly contagious. It is impossible for Epiphany to determine who has COVID and who does not. Being indoors especially increases the probability of acquiring COVID, if someone who is contagious is present.
2. Anyone part of an "at higher risk population" (e.g., age 60 or older, asthma, HIV, immuno-compromised, heart, lung liver or kidney disease, diabetes, or otherwise at risk for severe illness), should consult with their personal health care provider prior to attending any meeting or entering the premises of Epiphany Lutheran Church (*in or outdoors*).
3. **No one who has tested positive for COVID-19 in the last 14 days, been directed by a medical professional or a health department representative to quarantine, should come to Epiphany Lutheran or enter the premises (*in or outdoors*). The same is true for anyone who has felt ill in anyway, including the following symptoms, but not limited to these symptoms:**
 1. Fever
 2. Cough
 3. Shortness of Breath
 4. A decrease or change in the sense of taste or smell
 5. Sore throat/ stuffy nose/runny nose
 6. Body aches / chills /pains or unexplained fatigue
 7. Nausea, vomiting or diarrhea
 8. Pink eye or conjunctivitis
 9. Unexplained new skin rashes/ skin lesions/toe changes
4. **No one who has been in contact with anyone who has tested positive for COVID-19 in the last 14 days, or has had contact with anyone that has had the above stated symptoms in the last 14 days, should come to or enter the premises of Epiphany Lutheran Church (*in or outdoors*) until 14 days have passed from the last exposure to that person.**
5. **Anyone who tests positive for COVID-19 or is informed by a health care professional that they may have COVID-19 within 14 days of being on Epiphany's premises (*in or outdoors*), must notify Pastor Libbie immediately so contact tracing can occur, if needed.**
